Reports and Parishioner's Question Time

Mrs Sheelah Cook attended the meeting to thank everyone who had helped with distributing the parish magazine which enclosed tickets for the St Peters Church Fete, the fete raised £3,100.

Norfolk County Council (NCC): The chairman read out a report from County Councillor Roper.

The main County issue is the Crostwick Lane/North Walsham Road junction and the opportunity for a site meeting next week.

In other highways matters Councillor Roper has made a request to the Highway Engineer for an inspection of the Crostwick Lane speed bumps.

Main issue at NCC since the last meeting has been the rising cost of the Norwich Western Link. The total cost has increased from £198m to £251m - however it remains the hope that government will fund 85% of the project. If this is the case the additional cost to Norfolk will be just under an additional £8m. What would be a potential game changer is if government funds less than 85% of the new project cost. There are still many stages to go through but the Council remains committed to completion of the road.

The other issue is preparations for next year's budget. This will involve a consultation over the summer on a review of the mobile library service. From October onwards there will be the usual main budget consultation but ideas already put forward include more on street parking charges in tourist areas and potential changes to opening times at recycling centres.

7.PLANNING MATTERS

Ref: 20220941

Location: 9 Fieldfare Close, Spixworth, NR10 3RA

Description: Single storey rear extension

Comments: The parish council noted that one of the walls was extremely close to the boundary and requested that the clerk feed this back to the planning authority.

Councillor Barrell questioned if the Parish Council had been made aware that the developer was going to cut down the trees at the entrance to the new development on Buxton Road. The council asked the clerk to check the planning application to make sure this had been identified.

Councillor Knight questioned whether the trees would be planted elsewhere.

9. HIGHWAY MATTERS

Councillor S Vincent reported that the drains on Buxton Road have still not been cleared despite this matter being reported at several previous parish council meetings and reported to Councillor Roper and NCC Highways.

Councillor Barrell reported that following on from an article in the Evening News Spixworth was reported as being the 3rd highest for recorded speeding vehicles.

Councillor Knight reported that the speed humps on Crostwick Lane need repairing.

It was reported that the road is sinking on Godfrey Road outside the shop.

10. AMENITY MATTERS

10.2 A resident reported that a sweet chestnut tree on Greg's Meadow is overhanging into her garden. This had been reported by the same resident last year and work was carried out by the parish council to have it cut back. The council agreed that they will not be carrying out annual cuts on trees unless its absolutely necessary. The chairman offered to take a look and report back, the council agreed to have it cut back this year but will review it year on year.

10.3 The clerk confirmed that Rospa had carried out their annual safety inspection on the parish play areas and gym equipment located on Greg's Meadow. Clerk to circulate reports. It was agreed that individual councillors would carry out a

monthly check of the play/gym equipment and report back to the clerk if there are any safety concerns.

11. ALLOTMENT UPDATE

The clerk advised that Broadland Planning had still not held a site visit with the developer to carry out remedial work to get the allotments delivered. An office at Broadland who had been dealing with the matter over the last two years confirmed that he would be leaving and the matter would be passed to another colleague.

The parish council had also still not received an acknowledgement to their complaint letter that was sent to the managing director of Broadland on the 25th of April 2022 regarding the delay in delivering the allotments to the people of Spixworth.

Councillor S Vincent advised that it was down to the District Councillors to now chase the matter with the Director of Place at Broadland.

There being no further business the Vice Chairman closed the meeting at 9:33pm
