Reports and Parishioner's Question Time

Broadland District Council: Councillor Holland reported that Broadland are doing the community at heart awards for 2020, suggested putting forward volunteers of Spixworth Helping Hands. Consultation taking place for Norwich western link. With regards to the allotments for Spixworth councillor Holland reported that the developers are not engaging with Broadland District Council to resolve any matters concerning its transfer to the Trustee of Spixworth Village Hall. It was agreed that a meeting needs to be set up with Nigel Harris and Phil Courtier at BDC planning to get this resolved asap.

Norfolk County Council: Councillor Roper reported that he has not been able to get hold of Nigel Harris or Phil Courtier regarding the allotment transfer and has requested an urgent meeting before the end of September.

Councillor Roper spoke with highways engineer Ben Rayner at Norfolk County Council about the issue of siding out grass bank along Ivy and Buxton Road. Ben has advised that the works will be completed in the next few weeks. It was also suggested to extend 20mph zone along Ivy Road due to an accident that happened. Ben is looking into this. Crostwick Lane junction with North Walsham Road, setting costs aside Norfolk County Council Highways have responded that they see no barriers with regards to installing traffic lights and carrying out a petition to get this done. Ben Rayner is creating a plan on what the design process would be to have these traffic lights installed. There has been a Covid-19 outbreak at Banham Poultry with issues of test an trace. With regards to NCC budget, councillor Roper reported that money is coming through from the government, but finances will be tight next year. Cannot comment on what the council tax base will be. Local government is looking at another devolution deal, possible 3 unitary councils. Councillor Vincent asked if Spixworth could have a speed sign on Buxton Road which is able to record number plates. Councillor Roper advised that NCC would not fund this has the parish already had a SAM2 camera.
