Reports and Parishioner's Question Time

Councillor Dan Roper sent his apologies and provided an update which was circulated to all Parish Councillors.

Broadland District Council- Collaboration project with South Norfolk. This has been passed by the cabinet at both Councils and will go to a full council meeting next Thursday. This is not a merger between the Councils, they will continue to be entirely separate, and however under the scheme they will share a senior management team.

Norfolk County Council- There has been coverage on Radio Norfolk this morning about the reports of 30 accidents on the NDR since opening and the survey by presenters who identified 20 signs knocked down or damaged at the roundabouts. Along with other Councillors Councillor Roper will continue to press for further monitoring of the roundabouts, traffic on approach roads and also that when damage to road fixtures is reported that these are repaired/replaced in good time.

Councillor Roper has made visits to Mayton Wood recycling centre to see what the impact has been of the introduction of charging. It is of concern that the number of visits to centres has dropped considerably since charging was introduced. If there is not a change to policy on charging it is clear that better information needs to be issued, particularly on the large range of items that can still be deposited for free.

9. HIGHWAYS AND AMENITIES MATTERS

- 10.2 A locality grant submission form was recently completed payment has now been approved. This money will be used to further progress the Neighbourhood Plan project for Spixworth.

10.3 S Vincent provided feedback from the first Broadland Community led planning workshop. The workshops are held monthly except for August and are aimed at Parish and Town councils to learn more about planning and development and how to develop a community-led plan. This will mainly comprise a series of free workshops that will help parishes to understand how they can fully engage with and influence the planning system in order to get the best outcomes for their community.
