## **Reports and Parishioner's Question Time**

Mr P Mills attended the Parish Council Meeting on behalf of the Spixworth and District British Legion. Mr Mills informed the council that he has recently succeeded in resurrecting the Spixworth and District branch of the Royal British Legion.

The group has started fundraising to purchase a new Standard; the old previous standard was given as a gift to St Peters Church and can no longer be used. Once the new standard has been procured it will then be dedicated at a service at St Peters Church.

Mr Mills has asked the Parish Council if they can provide a donation towards the new standard, Councillor Vincent advised of additional funding from Broadland District Council which is obtained from community grants. Councillor Rowe offered up a personal donation and Councillor Self offered support from another committee it belongs to.

Councillor Dan Roper gave a report on the following:

Norfolk County Council- One more week to run on the Children Centres consultation.

There is a 4% increase on Council Tax.

Western Link public consultation to look at possible routes.

Councillor had a meeting with Mr D Allfrey of Norfolk County Council to discuss issues with NDR roundabouts. Changes have been made to Wroxham roundabout with only a 1 lane exit rather than 2, proposal to do the same to the North Walsham roundabout.

NCC are repairing signage and adding in more warning road markers to see if issues of queues are down to driver hesitation. D Roper feedback that the speed of traffic and size of roundabout doesn't help when indicating.

Broadland District Council- Handover period with the new chief executive

There is a 2<sup>nd</sup> stage call for new building sites, no additional ones for Spixworth

## 20171221-Land adjacent St Mary's Care Home, North Walsham Rd

5 No Supported Retirement Bungalows and Revised Car Parking Layout Councillors discussed new plan and on- going position of path, there is no change to the current 18 bungalows, but change for the 5 bungalows. Planning requirement different as not dependent on new proposed footpath.

Council to query with Broadland District Council as to why new plan does not show the original footpath for the 18 bungalows.

The Parish Council needs clarification on whether this is a change to the footpath location or an addition.

7.2 The Council agreed to object to Planning Application-20171221 due to the lack of information and incomplete plan provided by Broadland District Council, there is no footway access to the village and the 5 bungalows are isolated. Councillor Roper will call application into Committee.

#### 9. HIGHWAYS MATTERS

- 9.1 Councillor D Self is now working with the Spixworth Community Speed Watch Group and taken on the erecting and recording of data from the SAM2 camera. Councillor Self to notify Clerk when camera is moved to another location. The council would like to thank Councillor V Barrell for all is support and hard work with the SAM 2 camera and Councillor S Vincent for assisting.
- 9.2 Report received from Cozens Street Lighting showed that there were 14 streetlights in need of straightening and re concreting. Councillor D Self and V Barrell requested to look at the columns first before committing to repair works. Clerk to provide list of where lampposts are located. It was agreed that the upgrade to LED lights for all streetlight columns is added to the budget for review in 2019/20.
- 9.3 The Council discussed the uncut are located in front of 20 Orchard Road, it was believed that the grassed area belongs to Broadland District Council after discovering a hidden sign on the fence for no dog fouling. Clerk to investigate further.
- 9.4 Councillor D Self and Councillor K Harkin-Perry will meet with Norfolk County Council Highways Engineer, Mr Ben Rayner to discuss projects that can be carried out in Spixworth in relation to the Parish Partnership Bid.

## **10. AMENITY MATTERS**

10.1 It was agreed for the clerk to purchase 2 new notice boards, located on Ivy Road and Crostwick Lane, proposed by Councillor S Holland and seconded by Councillor V Barrell. Funds to be used from earmarked reserves (parish projects)

- 10.2 Clerk is awaiting a response from Hopkins Home and Broadland Distict Council regarding the repair work to the gate and re planting of trees before the Parish can officially take ownership of the amenity land on Crostwick Lane.
- 10.3 The Council discussed quotes for the CCTV upgrade at the Village Hall. Councillor S Vincent feels that the Village hall should cover the cost for the upgrade. Councillor S Holland advised that the Parish Council as Trustee should provide a donation towards the cost. It was agreed that the matter needs to be discussed further at the next Trustee meeting and that the Village Hall manager is to put the request in writing to the Trustee.
- 10.4 The gate bracket for Greg's Meadow located on Ivy Road/Cedar Avenue end to be repaired.
