

PHP shared details of her research so far, including some interesting snippets about Spixworth Hall.

The listed buildings were discussed and PH noted the change in the listing of St. Peters Church to Grade 1.

6 Sustainability Appraisal (SA) Scoping Report

SV presented the SA Scoping Report, previous circulated with the agenda papers, and the key sections were highlighted, discussed

and reviewed.

RI asked for clarification on page 10 about the area covered by the parish of Spixworth. SV confirmed it should read square miles.

The demographic data in section 5 was discussed in some detail.

Correct typo on page 34 – should readthere "are" 80 older people.....

Discussed the affordable homes and where these would be delivered. SV explained these would be in site allocation GT14.

Transport and access – the projected traffic flows in Map 17 Broadland Northway (Northern Distributor Road) were discussed. It was suggested it would be a good idea to compare the 2017 forecasts with the local SAM2 data.

RI identified the play area with access from Arthurton Road.

SM said she had a few changes which she would forward to SV.

County wildlife sites data – SM would look into details and numbers to enable inclusion in the final version of the scoping report.

It was agreed to proceed to consultation with the statutory bodies (Environment Agency, Historic England and Natural England) following completion of SM's updates.

7 Policy Update

The updated Emerging Policy Drafting document was discussed and the Group fed back their comments and what to include into the Neighbourhood Plan.

The Group agreed the policy intent statements.

Policy 1: limit to over a number (10 suggested) of dwellings

Policy 6: Group to identify areas to be included.

SV

Policy 7: to see if use of tree canopy area can be used.

Policy 8: Parish Council to be the preferred solution for open space management.

A number of the Design & Housing policies could be combined using the criteria to improve development.

RI asked about the NCC sprinklers in policy, SV advised that this would have to be in the text and evidence – as it cant be in the policy.

Discussion about draft Policy 14 Design and Housing - dementia friendly housing - PHP and SM referred to websites they had looked at with some interesting points around dementia friendly in design. PHP agreed to list elements she felt should be included. PHP and SM will circulate the website links to enable the Group to look at.
